

CONDITIONS AND INFORMATION ON THE PROCESSING OF PERSONAL DATA AND GRANTING OF CONSENT

Contact form on the controller's website

under Article 6(1)(a), Articles 7 and 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, "GDPR")

I, as the data subject, **consent to the processing of my personal data by the**

Purpose: Handling of suggestions and questions addressed to the Controller via the contact form published on the Controller's website.

Recipients / categories of recipients: Entities to whom personal data are provided as required by law and the company providing website's operation and administration.

The contact form is not intended for persons under the age of 18. Filling in the contact form and the related provision of personal data is a free expression of the data subject's will. Without giving the consent to the processing of personal data by ticking the box "I consent to the processing of personal data" it is not possible to submit the contact form.

This consent to the processing of personal data is a freely given, specific, informed and unambiguous indication of my will. Before giving my consent, I was informed about the following facts:

The provision of personal data is not a statutory or contractual requirement, or a requirement necessary to enter into a contract.

Retention period: The consent is valid until the end of the year following the year in which it is given.

Transfer of personal data to a third country or international organisation: None.

Automated decision-making, including profiling: None.

Data subject rights:

The data subject has the right to withdraw his or her consent at any time, without affecting the lawfulness of processing based on consent given before its withdrawal.

Irrespective of the legal basis for processing of personal data, the data subject has **the right of access to the personal data** concerning him or her, **the right to rectification and erasure of personal data**, **the right to restriction of processing**, **the right to data portability** and, if justified, **the right to lodge a complaint with the supervisory authority**, which is the Office for Personal Data Protection of the Slovak Republic, with its registered office at Budova Park One, Námestie 1. mája 18, 811 06 Bratislava, statny.dozor@pdp.gov.sk, <https://dataprotection.gov.sk/> or **the right to file a petition for commencement of proceedings on protection of personal data**.

Withdrawal of consent: The data subject may exercise the right to withdraw consent at any time, even before expiry of the period for which such consent was given, in the following ways:

- sending an email to ochranaou@eustream.sk, with the subject line "GDPR - consent withdrawal",
- coming in person to the company's registered office, or
- sending a written request in an envelope bearing a notice "GDPR – consent withdrawal" to the address of the Controller's registered office.
