

## **INFORMATION ABOUT PERSONAL DATA PROCESSING**

### **Limitation of ownership rights**

**Purpose of processing:** Provision of financial compensations to the affected forest land owners for the limitation of their ownership rights under the Act No 326/2005 on forests;

- a) Contacting the affected forest land owners at the preparatory stage for the purposes of possible conclusion of contractual relationships with them;
- b) Preparation and drafting and delivery of (pre-contract) compensation agreements to the affected owners;
- c) Conclusion of the agreements and record-keeping of amendments thereto; performance of the agreements (provision of financial compensations); business communication; registration in the Land Registry; enforcement of contractual obligations and claims.

### **Legal basis for the processing:**

- a) The controller processes personal data for the purposes of contacting the affected land owners in order to carry out the legal obligation to provide compensations to those land owners for the limitation of their ownership rights; this constitutes processing necessary for compliance with a legal obligation to which the controller is subject, i.e. based on the legal basis provided in Article 6(1)(c) of the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation). The relevant provisions from which the controller's legal obligation referred to above derives are Articles 35 et seq. of the Act No 326/2005 on forests.
- b) The controller processes data necessary for the preparation and drafting of (pre-contract) compensation agreements with the affected owners; this constitutes processing based on the legal basis provided in Article 6(1)(b) of the General Data Protection Regulation.
- c) The controller processes data necessary for the conclusion of (contractual) compensation agreements with the affected owners; this constitutes processing based on the legal ground provided in Article 6(1)(b) of the General Data Protection Regulation.

### **The period for which personal data will be stored:**

- a) 10 years following the year to which the data relate.
- b) 10 years following the year to which the data relate.
- c) 10 years following the year to which the data relate.

### **Recipients / recipient categories:**

- a) postal service providers and other entities to which the controller provides personal data on the basis of law; expert consultants and advisers bound by a legal and/or contractual confidentiality obligation.
- b) lawyers and other entities to which the controller provides personal data on the basis of law; expert consultants and advisers bound by a legal and/or contractual confidentiality obligation.
- c) lawyers; the public prosecution service; courts; administrative authorities; Land Registry; bailiff's offices; postal service providers and other entities to which the controller provides personal data on the basis of law; expert consultants and advisers bound by a legal and/or contractual confidentiality obligation.

**Personal data category:** The controller processes mainly contact and identification data, such as the degree, name, surname, address and other personal data appearing in an ownership document, where appropriate.

**Source of personal data:** Publicly available sources of information and registries, such as the Land Registry.

**Request for the disclosure of personal data and potential consequences of non-disclosure:** The provision of personal data is a contractual requirement. The data subject is legally obliged to provide his or her personal data. Non-provision of data would prevent the conclusion of the contract or agreement.

**Transfer of personal data to a third country or an international organisation:** None.

**Automated decision-making, including profiling:** None.

**The data subject's rights:**

The data subject has the **right of access to personal data; right to rectification, erasure and restriction of processing of personal data; right to portability of personal data; and right to lodge a complaint with the supervisory authority**, which is the Office for Personal Data Protection of the Slovak Republic.
