Tariffs for calendar year 2024 for EU interconnection Points¹ (period 01.01.2024 – 31.12.2024)

The final reference prices for the EU Interconnection Points, which will be also the reserve prices for the yearly standard capacity products for these points, have been set in accordance with the price decision of the Regulatory Office for Network Industries No. 0040/2019/P of 29 May 2019, valid for period beginning from 01.01.2022. The Regulatory Office for Network Industries has set the final reference prices after application of the benchmarking for the year 2022 (point 4) by the respective decision. For subsequent calendar years, the Regulatory Office for Network Industries has determined that the final reference prices after the benchmarking application will be adjusted by the index $IR_{(t-2)}$ – the inflation index in the European Union published by Eurostat, the item "HICP – annual average rate of change – European Union (annual average inflation rate - European Union)" valid in a calendar year (t-2) (point 11.1.). Tariffs for the EU Interconnection Points for the calendar year 2024 have been escalated by 9.2 % (from the valid tariffs of the year 2023) according to the point 11.1. of the respective price decision No. 0040/2019/P of 29 May 2019.

Tariffs for calendar year 2025 for EU interconnection Points (period 01.01.2025 – 31.12.2025)

The final reference prices for the EU Interconnection Points, which will be also the reserve prices for the yearly standard capacity products for these points for calendar year 2025, have been set in accordance with the price decision of the Regulatory Office for Network Industries No. 0001/2025/P of 05 June 2024 (point 4.), valid for period from 01.01.2025 till 31.12.2027, which amends the price decision No. 0040/2019/P of 29 May 2019. The final reference prices determined for the calendar year 2025 will also be valid for other years of the tariff/regulatory period in case that there is no amendment in the price decision or cancellation and replacement of the price decision with a new price decision during this period in connection with the reference prices.

According to the price decision No. 0001/2025/P of 05 June 2024 the prices, tariffs and conditions of their application for access to the transmission network and gas transmission will be applied to contracts on access to the transmission network and gas transmission according to the price decision valid and effective for the period for which the relevant transmission capacity is allocated (regardless of the date of its allocation) (i.e. in the case of contracts on access to the transmission network and gas transmission concluded even before the amendment of the relevant price decision or the cancellation and replacement of the relevant price decision with a new price decision, for the capacities allocated for the period during the validity and effectiveness of such amendment of the relevant price decision or validity and the effectiveness of the new price decision will apply the prices, tariffs and conditions of their application for access to the transmission network and gas transmission according to such an amendment of the relevant price decision or according to the new price decision), with the exception of contracts concluded before the entry into force of the decision of the Regulatory Office for Network Industries No. 0002/2015/P-PP dated 25 March 2015, unless expressly stated otherwise.

¹ Entry/exit points Lanžhot, Baumgarten, Veľké Zlievce and Výrava are interconnection points according to the Commission Regulation (EU) 2017/459 of 16 March 2017 establishing a network code on capacity allocation mechanisms in gas transmission systems and repealing Regulation (EU) No 984/2013 ("EU Interconnection Points").
