**Purpose of processing:** Processing personal data as part of the supplier selection and supplier registration process (including demonstrating the professional competence and qualification of third-party welders) including providing documents during the performance of external audits and other statutory inspections.

**Legal basis for the processing:** The controller's legitimate interest within the meaning of Article 6(1)(f) of the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data General Data Protection Regulation).

**The Controller's legitimate interests:** Property protection, including the consistent provision of safeguards to secure the critical infrastructure elements, through the verification of facts declared by a supplier at the time of procurement, including professional competence.

**Recipients/recipient categories:** PROEBIZ s.r.o., the provider of procurement support services; the Regulatory Office for Network Industries of the SR; external auditors and other entities to which the controller provides personal data on the basis of law; expert consultants and advisers bound by a legal and/or contractual confidentiality obligation.

The period for which the personal data will be stored: 5 years following the year to which the data relate.

**Personal data category:** The controller processes mainly contact and identification details such as the title, name, surname, job position, address, electronic mail address at work, telephone number and personal data concerning professional competence.

**Source of personal data:** A business partner's representative providing personal data of its employees or of its subcontractors' employees to the controller.

Transfer of personal data to a third country or an international organisation: None.

Automated decision-making, including profiling: None.

The data subject's rights:

The data subject has the **right of access to personal data**; **right to rectification, erasure and restriction of processing of personal data**; and **right to lodge a complaint with the supervisory authority**, which is the Office for Personal Data Protection of the Slovak Republic.

The data subject has the **RIGHT TO OBJECT to the processing of personal data** relating to him or her, **including objecting to profiling**.

If such objection is made **the controller shall no longer process the personal data** unless it demonstrates

- compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject; or
- grounds for the establishment, exercise or defence of legal claims.
