A. Non-binding Demand indications

This analysis in line with the Regulation (EU) 2017/459 includes non-binding demand indications received within 8 weeks after the 1 July 2019.

The involved TSOs, NET4GAS and eustream, have not received any non-binding demand indications for firm capacity at the interconnection point between the entry-exit system of NET4GAS and the entry-exit system of eustream for any future period. No non-binding demand indications submitted after the deadline referred to in Art. 26 paragraph 6 of Regulation (EU) 2017/459 were received after the 2017 incremental capacity process.

Therefore, the amount of 0 for non-binding demand indications has been used as a basis for this demand assessment.

B. Demand assessment

i. Expected amount, direction and duration of demand for incremental capacity

The received demand indications within the current incremental process between the entry-exit system of NET4GAS and the entry-exit system of eustream are zero. The potentially available capacity (i.e. technical capacity which is not yet booked in the long term) for the requested period is currently sufficient to cover potential future need for capacity.

C. Conclusion for the (non)-initiation of an incremental capacity project/process

According to the assessment result of the non-binding demand indications under point B, no demand levels for incremental capacity need to be developed and hence, no incremental capacity project will be initiated by the involved TSOs.

Based on the aforementioned decision, no technical studies for incremental capacity projects will be conducted.
